# **APPENDIX A: GENERAL INFORMATION REGARDING AGRICULTURAL PUMPS ON SOVEREIGN LANDS**

1. **Permit Fees:** In addition to the \$50.00 application fee, agricultural pumps and related structures will generally be assessed a one-time permit fee of \$50.00 for pumps/structures that do not require significant modification or disturbance of the bed or banks of the sovereign land resource and \$150.00 for pumps/structures that do require more significant modifications or disturbances. However, we have worked with the legislature to waive these permit fees for all applications received prior to July 1, 2019.
  2. **Permit Term:** General permits for agricultural pumps and related structures will generally be issued for a period of 10 years unless otherwise specified.
