#### **Bear Lake Comprehensive Management Plan**

Introduction

Pursuant to Utah Code 65A-2-2 and 65A-2-4 and the implementing regulations of Utah Administrative Code R652-90, the Utah Division of Forestry, Fire & State Lands (FFSL or the division) is empowered to prepare and adopt comprehensive management plans for sovereign lands and resources. FFSL initiated the Bear Lake Comprehensive Management Plan (Bear Lake CMP) process to replace the existing 2009 Bear Lake CMP (FFSL 2009). The process has included interagency cooperation and collaboration with open public participation.

The primary purpose of the Bear Lake CMP is to guide FFSL, along with adjacent landowners and other local, state, and federal partners, in managing and appropriately using Bear Lake's sovereign land resources. The Bear Lake CMP clearly sets forth defined management goals and objectives for guiding and directing future resource management actions, activities, and recreation uses on Bear Lake.

In compliance with policy, procedures, rules, and statutes for comprehensive management planning, FFSL has completed the updated CMP for the planning area. Therefore, FFSL issues this record of decision for the Bear Lake CMP.

#### **Description of Lands Directly Affected**

According to Utah Administrative Code R652-70-2300(1), lands lying below the ordinary high water mark (OHWM) of Bear Lake at the date of statehood are owned by the State of Utah and shall be administered by FFSL as sovereign lands. In the absence of evidence establishing the OHWM at the date of statehood, FFSL administers "all the lands within the bed of Bear Lake and lying below the level of 5,923.65 feet above mean sea level, Utah Power and Light [UP&L] datum, as being sovereign lands" (Utah Administrative Code R652-70-2300(3)). Therefore, the shoreline and bed of Utah's portion of Bear Lake lying below this elevation are considered sovereign lands managed by FFSL. All lands and resources beneath this lake elevation constitute the planning area for this CMP.

FFSL recognizes that certain title and boundary questions may have to be addressed on a case-by-case basis. Utah Administrative Code R652-70-2300(4) and Utah Code 65A-10-1 and 65A-10-3 give FFSL the authority to settle sovereign land boundaries with affected state agencies and any person owning land adjoining the bed of Bear Lake, as long as the settlements do not set a boundary for sovereign lands below the 5,923.65-foot elevation point (UP&L datum). In 1999, FFSL started negotiating with individual adjacent landowners to establish the sovereign land boundary. Since then, FFSL has streamlined the boundary settlement process and plans to continue the process until all boundaries are settled adjacent to the lake.

#### **Proposed Action**

The proposed action associated with this record of decision is the adoption and implementation of the 2022 Bear Lake CMP.

#### **Relevant Factual Background**

Through a rigorous competitive process, FFSL hired SWCA Environmental Consultants (SWCA) to facilitate the development of the 2022 Bear Lake CMP. SWCA engaged the following entities to assist in developing the plan:

- CRSA, a local planning firm
- John Gangemi, River Science Institute, a water-based recreation expert
- Claudia Conder, a water rights expert

The Bear Lake CMP planning process began in August 2019. FFSL was interested in improving cooperative management, planning, and research activities within the Utah Department of Natural Resources and incorporated many of this department's agencies into the Bear Lake CMP planning team. Representatives from the Idaho Department of Lands, Utah Division of Water Quality, Utah Division of State History, Bear River Association of Governments, Bear Lake Regional Commission, Rich County Commission, Rich County Sheriff's Office, Town of Garden City, Bear Lake Watch, adjacent landowners, and recreation business owners were also included on the planning team.

As part of the planning process, the Bear Lake CMP planning team members provided input and technical support relevant to their area of expertise throughout the process. The purposes of the Bear Lake CMP planning team were to

- provide resource-specific guidance throughout the planning process;
- provide the most recent, relevant research and data pertaining to Bear Lake resources and associated uses;
- provide insight into management and jurisdictional roles;
- provide timely review and comment on the document throughout the planning process; and

offer project updates and opportunities for comment to State of Utah agencies and the general public.

The Bear Lake CMP planning process was designed to result in development of a current conditions assessment, desired future conditions, management goals, and management objectives and to encourage public participation throughout the process.

#### **Public Outreach**

The development of the Bear Lake CMP involved a 24-month public outreach process from September 2019 to September 2021. FFSL initiated the Bear Lake CMP planning process with a press release distributed on September 12, 2019. Notification of the planning process was made to the Resource Development Coordinating Committee (RDCC) on September 11, 2019. A list of planning process participants was developed from the following sources:

- Individuals or organizations (land-use applicants) holding an FFSL authorization
- All landowners adjacent to Bear Lake sovereign lands within the affected county
- Bear Lake stakeholders identified by the planning team
- Tribes identified by FFSL
- Local, state, and federal agencies identified as having jurisdictional authority in the project

FFSL and the SWCA team conducted two series of public open house meetings. The first series focused on kicking off the project and gathering information, and the second series focused on reviewing the draft Bear Lake CMP.

Open house format meetings were held in Rich County and Salt Lake County to kick off the public engagement process. Dates, times, and locations for these meetings are provided in Table 1.

Open house format meetings were also held to present the draft Bear Lake CMP and to initiate the formal public comment process. Dates, times, and locations for these meetings are provided in Table 2.

#### **Meeting Design**

At each of the first two open houses, FFSL provided a project overview presentation. Following this overview, FFSL and SWCA staff answered questions and facilitated information-gathering activities in an open house format, as applicable. Attendees were greeted; asked to sign in; provided information about the meeting format; and given the option of taking a brochure and/or business card with project details. Attendees were informed about ways to follow the planning process, provide information, and submit comments. They were encouraged to ask questions of the facilitators. During the third open house on June 3, 2021 (a virtual meeting), FFSL presented a slideshow that provided

background on the planning process, information from the draft CMP, and instructions on how to submit comments. After the slideshow, FFSL answered questions from participants. The fourth open house on June 5, 2021, was in the same format as open house series #1, except that it was held outdoors, and no formal presentation was given.

During open house series #1, display boards were arranged around the meeting room. The display boards provided opportunities for participants to write comments on the boards about what works well and what needs improvement for topics such as vegetation, wildlife, water quality, infrastructure, and recreation. One of the display boards also asked for specific comments on how changing lake levels affect participants and what FFSL can do to help.

During open house series #2, a different set of display boards was used to explain key information from the draft Bear Lake CMP, including lake use classes, lake level effects, the lake level matrix, use determinations for common proposed actions, and example goals and objectives.

#### **Meeting Advertising**

Pursuant to FFSL requirements, public open house meetings were advertised in a variety of formats before their scheduled dates. In each format, the advertisements provided logistics, explained the purpose of the meetings, gave the public comment period schedule if applicable, outlined methods to comment, and provided ways to obtain more information. Methods of communicating included direct emails, direct mail postcards, flyers posted at Bear Lake, the project website, the FFSL website, and FFSL press releases.

#### **ADVERTISING FOR PUBLIC OPEN HOUSES**

Meeting information for open house series #1 (kickoff and information gathering) was posted on the project website, and emails were sent on September 13, 2019; September 24, 2019; and November 6, 2019 (for the Salt Lake City open house).

Meeting information for open house series #2 (draft plan review) was posted on the project website, and emails were sent on May 13, 2021, and May 27, 2021.

Formal newspaper legal notices for open house series #1 (kickoff and information gathering) were posted on the following dates in 2019:

- Cache County Herald Journal (Cache County): September 14 and 21, 2019, and November 7, 9, 14, and 16, 2019
- Salt Lake Tribune (Salt Lake County): November 9 through 17, 2019
- Emailed the *Rich Civic Times* (Rich County) on September 9 and 14, 2019, to place a notice but received no response

Formal newspaper legal notices for open house series #2 (draft plan review) were posted as follows in 2021:

- Cache County Herald Journal (Cache County): May 15, 22, and 29, 2021
- Salt Lake Tribune (Salt Lake County): May 14, 21, and 28, 2021
- Rich Civic Times (Rich County): May 17, 24, and 31, 2021

Flyers with information on the open houses were also placed by FFSL at key Bear Lake locations ahead of each open house series.

The following invitations were sent to inform interested participants of the open houses:

- Emails sent in September and November 2019 for open house series #1 (kickoff and information gathering)
- Postcards sent to current lessees and adjacent landowners in September and November 2019 for open house series #1 (kickoff and information gathering)
- Emails sent in May 2021 for open house series #2 (draft plan review)

 Postcards sent to current lessees and adjacent landowners in May 2021 for open house series #2 (draft plan review)

The formal comment period began on May 17, 2021. The last day of the public comment period was initially June 21, 2021; however, at the request of stakeholders, the comment period was extended two separate times to end on September 17, 2021. Emails and postcards were sent to notify stakeholders of the extended comment periods. This resulted in a total comment period of 124 days. The final Bear Lake CMP and record of decision were posted to the FFSL website on February 24, 2022. FFSL sent final postcards and emails of the issued record of decision on February 25, 2022. Petitions for consistency review were to be received by March 17, 2022.

#### **Public Trust**

As stated in the Bear Lake CMP, the purpose of the plan is to prescribe management goals and objectives for Bear Lake sovereign lands and to ensure that navigation, fish and wildlife habitat, aquatic beauty, public recreation, and water quality (Public Trust resources or values) are given due consideration and balanced against the economic necessity, justification for, or benefit to be derived from any proposed use, pursuant to Utah Administrative Code R652-2-200. Primary management responsibility for the lake's resources lies with FFSL pursuant to Utah Code 65A, which governs management of all state lands within the jurisdiction of FFSL. Utah Code 65A-2-1 states that FFSL "shall administer state lands under comprehensive land management programs using multiple-use, sustained-yield principles."

The overarching management objectives of FFSL are to balance the use of and sustain the Public Trust resources and to provide for reasonable beneficial use of those resources consistent with their long-term protection and conservation. The 2022 Bear Lake CMP was designed to facilitate FFSL's management of Bear Lake and its resources under these principles.

#### **Interagency Coordination**

Interagency coordination and communication are essential because multiple government agencies are involved with various Bear Lake resources and uses. During the Bear Lake CMP planning process, FFSL understood the importance of working with the Bear Lake CMP planning team. As outlined in Utah Code 65A-2-2, FFSL may request support for implementation of state land management plans and to this end seeks to maintain support across state agencies as it implements the 2022 Bear Lake CMP. Chapter 3, Section 3.6 of the Bear Lake CMP outlines the proposed coordination framework to be carried out by FFSL and other state agencies tasked with research, management, and permitting on Bear Lake. The Bear Lake CMP management strategies allow numerous opportunities for coordination with respect to Bear Lake resources.

#### **Public Outreach: Notification, Comment, and Review**

Public outreach was essential to the Bear Lake CMP planning process. As outlined earlier in this decision document, the public had numerous opportunities to contribute to the Bear Lake CMP, and many did. As required by Utah Administrative Code R652-90-500, FFSL notified RDCC about the planning process and about the draft Bear Lake CMP on September 11, 2019, and May 13, 2021, respectively. The project was made available for public comment on the Project Management System website (Exhibit A). However, no comments were received via RDCC during the planning process. Stakeholders were notified multiple times throughout the planning process requesting their attendance at public meetings and requesting their comments. Notification for open house series #1 was sent by postcard to approximately 438 addresses and by email to approximately 62 email addresses. For open house series #2, notification was sent by postcard to approximately 438 addresses and by email to approximately 81 email addresses. The final announcement of this record of decision was sent by postcard to approximately 438 addresses (Exhibit B) and by email to approximately 90 email addresses. The formal 124-day public comment period for the draft Bear Lake CMP began on May 17, 2021, and ended on September 17, 2021. The public comment period followed the release of the draft Bear Lake CMP and coincided with the

second round of public outreach meetings. Comments were accepted by comment response forms at public meetings, on the project website, by email, and by postal mail.

Information from the public, stakeholders, and agencies was received throughout the planning process. FFSL received 21 written submissions commenting on the draft Bear Lake CMP. Verbal comments were also noted at both open house series. Comments referenced topics such as lake levels, irrigation withdrawals, parking, motorized access, sediments, water quality, fish, the shoreline, carrying capacity, education, desired future conditions, and Bear Lake CMP goals. From the written submissions, 131 individual comments were extracted for review. Comments on the draft Bear Lake CMP were acknowledged and addressed, as appropriate, by FFSL. As required by rule and statute Utah Administrative Code R652-90-600 (1)(b-d) and Utah Code 65-A-2-4, respectively, comment responses are provided in the final Bear Lake CMP (Appendix B).

### **Constitutional Provisions, Statutes, and Administrative Rules**

#### Utah Constitution Article XX, Section 1

The Utah Constitution Article XX, Section 1 states the following:

All lands of the State that have been, or may hereafter be granted to the State by Congress, and all lands acquired by gift, grant or devise, from any person or corporation, or that may otherwise be acquired, are hereby accepted, and ... are declared to be the public lands of the State; and shall be held in trust for the people, to be disposed of as may be provided by law, for the respective purposes for which they have been or may be granted, devised or otherwise acquired.

#### Utah Code 65A-2-1. Administration of State Lands --Multiple-Use Sustained-Yield Management

Utah Code 65A-2-1 states the following:

The division shall administer state lands under comprehensive land management programs using multiple-use sustained-yield principles.

#### Utah Code 65A-2-2. State Land Management Planning Procedures for Natural and Cultural Resources --Assistance from other State Agencies -- Division Action

Utah Code 65A-2-2 states the following:

The division:

- (1) shall develop planning procedures for natural and cultural resources on state lands; and
- (2) may request other state agencies to generate technical data or other management support services for the development and implementation of state land management plans.

#### Utah Code 65A-2-4. State Land Management Plans --Division to Adopt Rules for Notifying and Consulting with Interested Parties

Utah Code 65A-2-4 states the following:

- (1) The division shall adopt rules for notifying and consulting with interested parties including the general public, resources users, and federal, state, and local agencies on state land management plans.
- (2) Division rules shall provide:
  - (a) for reasonable notice and comment periods; and

(b) that the division respond to all commenting parties and give the rationale for the acceptance or non-acceptance of the comments.

#### Utah Code 65A-10-1. Authority of Division to Manage Sovereign Lands

Utah Code 65A-10-1 states the following:

(1) The division is the management authority for sovereign lands, and may exchange, sell, or lease sovereign lands but only in the quantities and for the purposes as serve the public interest and do not interfere with the public trust.

# Utah Administrative Code R652-2-200. Sovereign Land Management Objectives

Utah Administrative Code R652-2-200 states the following:

The state of Utah recognizes and declares that the beds of navigable waters within the state are owned by the state and are among the basic resources of the state, and that there exists, and has existed since statehood, a public trust over and upon the beds of these waters. It is also recognized that the public health, interest, safety, and welfare require that all uses on, beneath or above the beds of navigable lakes and streams of the state be regulated, so that the protection of navigation, fish and wildlife habitat, aquatic beauty, public recreation, and water quality will be given due consideration and balanced against the navigational or economic necessity or justification for, or benefit to be derived from, any proposed use.

# Utah Administrative Code R652-70-200. Classifications of Sovereign Lands

Utah Administrative Code R652-70-200 states the following:

Sovereign lands may be classified based upon their current and planned uses. A synopsis of some possible classes and an example of each class follows. For more detailed information, consult the management plan for the area in question.

- 1. Class 1: Manage to protect existing resource development uses. The Utah State Park Marinas on Bear Lake and on Great Salt Lake are areas where the current use emphasizes development.
- 2. Class 2: Manage to protect potential resource development options. For example, areas adjacent to Class 1 areas which have the potential to be developed.
- 3. Class 3: Manage as open for consideration of any use. This might include areas which do not currently show development potential but which are not now, or in the foreseeable future, needed to protect or preserve the resources.
- 4. Class 4: Manage for resource inventory and analysis. This is a temporary classification which allows the division to gather the necessary resource information to make a responsible classification decision.
- 5. Class 5: Manage to protect potential resource preservation options. Sensitive areas of wildlife habitat may fall into this class.
- 6. Class 6: Manage to protect existing resource preservation uses. Cisco Beach on Bear Lake is an example of an area where the resource is currently being protected.

# Utah Administrative Code R652-90-300. Initiation of Planning Process

Utah Administrative Code R652-90-300 states the following:

1. A comprehensive planning process is initiated by the designation of a planning unit as planning priorities are established by the division.

# Utah Administrative Code R652-90-500. Notification and Public Comment

Utah Administrative Code R652-90-500 states the following:

- 1. Once a planning unit is designated, notice shall be sent to the RDCC through the project management system.
- 2. The division shall conduct at least one public meeting in the vicinity of a planning unit that has been designated for a comprehensive management plan.
  - (a) The meeting shall provide an opportunity for the public to submit written comment regarding the issues to be addressed in the plan
  - (b) The public meeting shall be held at least two weeks after public notice.
  - (c) Notice of public meeting shall be sent directly to lessees of record, local government officials and adjacent landowners.
  - (d) Additional public meetings may be held.

#### Utah Administrative Code R652-90-600. Public Review

Utah Administrative Code R652-90-600 states the following:

- 1. Comprehensive management plans shall be published in draft form on the division's website and sent in electronic format to the RDCC and other persons upon request.
  - (a) A public comment period of at least 45 days shall commence upon receipt of the draft in the RDCC.
  - (b) All public comment shall be acknowledged pursuant to Subsection 65A-2-4(2).
  - (c) The division's response to the public comment shall be summarized in the final comprehensive management plan.
  - (d) Comments received after the public comment period shall be acknowledged but need not be summarized in the final plan.

# Utah Administrative Code R652-90-800. Multiple-Use Framework.

Utah Administrative Code R652-90-800 states the following:

Comprehensive management plans shall consider the following multiple-use factors to achieve sovereign land-management objectives:

- 1. The highest and best use for the sovereign land resources in the planning unit.
- 2. Present and future use for the sovereign land resources in the planning unit;
- 3. Suitability of the sovereign lands in the planning unit for the proposed uses;
- 4. The impact of proposed use on other sovereign land resources in the planning unit;
- 5. The compatibility of possible use as proposed by general public comments, application from prospective users or division analysis; and
- 6. The uniqueness, special attributes and availability of resources in the planning unit.

#### **Findings of Fact**

- 1. As described herein, FFSL notified the public and local, federal, and state agencies, including the RDCC, of the Bear Lake CMP planning effort.
- 2. As described herein, FFSL conducted public meetings in conjunction with the Bear Lake CMP planning effort.
- 3. As described herein, FFSL published a draft of the Bear Lake CMP and accepted comments from the public and other government entities and responded to all comments properly submitted.
- 4. FFSL considered and implemented legislative directives and resolutions concerning the content of the Bear Lake CMP.

#### **Conclusions of Law**

- 1. FFSL properly initiated the planning process for a comprehensive management plan by designating the planning unit and planning priorities established by FFSL.
- 2. FFSL fulfilled its notification requirements to lessees, to local governments, and to the RDCC when the project was initiated. FFSL went beyond its required notification by also notifying adjacent landowners and stakeholders.
- 3. The notification requirements for the public meetings have been met or exceeded.
- 4. The public review requirements have been met or exceeded.
- 5. FFSL properly responded to comments received in compliance with the applicable law.
- 6. The Bear Lake CMP fulfills the requirements of applicable statutes, rules, policies, and legal doctrines.
- 7. The planning process and subsequent Bear Lake CMP comply with the legal requirements for a comprehensive management plan and specifically comply with the requirements for the Bear Lake CMP.

#### **Decision and Order**

Based on the foregoing, FFSL hereby adopts the Bear Lake CMP (including Appendices A, B, and C), which satisfies the requirements of applicable statutes, rules, and policies. The Bear Lake CMP (including Appendices A, B, and C) becomes the comprehensive management plan that guides decision-making on the sovereign lands within the planning area. The Bear Lake CMP supersedes any and all previous management plans—adopted, draft, or otherwise—and represents the official position of FFSL.

#### **Administrative Appeals**

Parties having an interest in this action may file a petition for administrative review by the division pursuant to Utah Administrative Code R652-9. Said petition must be in writing and shall contain


- 1. the statute, rule, or policy with which the division action is alleged to be inconsistent;
- 2. the nature of the inconsistency of the division action with the statute, rule, or policy;
- 3. the action the petitioner feels would be consistent under the circumstances with statute, rule, or policy; and
- 4. the injury realized by the party that is specific to the party arising from division action. If the injury identified by the petition is not peculiar to the petitioner as a result of the division action, the director will decline to undertake consistency review.

Said petition must be received by the division by 5:00 p.m. on March 17, 2022.
